Note: Nearly all New Zealand citizens in Australia, who are not also Australian citizens, are the holders of a temporary visa called a Special Category Visa. This is NOT a permanent resident visa.

D. Essential Information

Full details of residency requirements for HECS-HELP and FEE-HELP are published in the booklets "Commonwealth supported places and HECS-HELP information" and "FEE-HELP Information" published by the Department of Education, Skills and Employment.

If you are a New Zealand citizen or the holder of a Permanent Resident visa you are not eligible to defer your fees through any of the government HELP schemes. You are required to pay your fees upfront and in full by the advertised due date each session.

HECS-HELP

Some Commonwealth Supported students are eligible to access HECS-HELP to assist in paying their student contribution. You may be eligible if you are:

- an Australian citizen, or
- the holder of a Permanent Humanitarian visa or
- a New Zealand citizen who is also a Special Category Visa (SCV) holder, and you meet the requisite residency criteria

FEE-HELP

Domestic Fee-Paying students may be eligible to apply for FEE-HELP, if you are:

- an Australian citizen, or
- the holder of a Permanent Humanitarian visa

SA-HELP

If you are an Australian citizen, the holder of a permanent humanitarian visa or an **eligible** New Zealand citizen, you may be eligible for a SA-HELP loan.
