





While enrolled in a Bachelor of Arts, Milan Sharma studied both economics and international relations, befriending a few undergraduate law students along the way. The experience piqued her curiosity and paved the way for postgraduate law study, with the BA graduate now enrolled in a Juris Doctor at UTS.

"UTS Law has a practical method for preparing law students, which is fantastic as it gives students who do not currently have a job in the legal sector a glimpse of the work conducted in a law firm. The Commercial Law and Equity & Trusts subjects required students to complete mock formal advice for a hypothetical client. With the teaching staff having practical legal experience, it allowed for strong and robust discussions about cases our tutors have worked on, and allowed students to engage more practically."

Milan has enjoyed the hands-on experiences outside of the classroom too, by taking part in the range of extracurricular activities available.

"Being involved in competitions and extra-curricular at UTS has not only

enabled me to create new friendships but I have been able to test my soft legal skills and gain experience through competitions. Particularly during the COVID-19 lockdown competitions proved to be a great way to upskill and maintain social relationships with my peers."


While postgraduate study has proven to be a big commitment, Milan shares that having a strong support network has helped her stay on track and get through the stressful moments.

For his undergraduate degree, Emmanuel Georgouras studied a Bachelor of Socio-Legal Studies and majored in History. He then worked for several years in the commercial world as a business developer before deciding he needed a postgraduate qualification.

Becoming a lawyer

In Australia, legal practice is regulated at state level.

In NSW you must satisfy the requirements of the Legal Profession Admission Board (LPAB) in order to practise law. The study path for entry to the legal profession in NSW begins with undertaking an accredited law degree. Then, in order to be eligible for admission to practice, it is necessary to complete an accredited program of practical legal training (PLT).

Overseas Qualified Lawyer

If you are an international lawyer seeking admission to practice in Australia, you need to have your overseas legal qualification assessed by the Legal Profession Admission Board (LPAB). The LPAB assessment determines the number of subjects (academic and/or PLT) you need to complete in order to be eligible to practise law in Australia. Once you receive the assessment from the LPAB, send a copy to law@uts.edu.au and we'll create a tailored plan that meets the requirements.

Lawyers, solicitors and barristers

Lawyer is a broad term that refers to both solicitors and barristers.

For the most part, solicitors provide general legal advice to their clients. Their role also includes settling disputes, drafting documents, directing negotiations and/or representing their clients in court or tribunal proceedings.

Barristers are specialist advocates and spend the majority of their practice presenting cases in court or formal hearings on behalf of their clients. Barristers are likely to specialise in certain areas of the law, for example criminal law. They also provide specialist legal advice and act as mediators, arbitrators, referees or conciliators. Barristers are independent practitioners and are generally referred clients by solicitors who provide the background 'brief' on a case.

PINY LY Transformation Coach and International Law/Business Specialist

With business and law skills developed at UTS, Piny Ly's degree opened a lot of doors - she worked at King & Wood Mallesons before being tapped on the shoulder for a job in CBA's International Financial Services Division in Hong Kong.

But a chance introduction to the work of the Cambodian Children's Fund (CCF) led her to Phnom Penh, where she reconnected with her cultural heritage while working with CCF. At CCF, Piny led a project helping the organisation's global boards work more efficiently through best practice governance processes. In March 2020, she became the first Cambodian appointed to the board of CCF Hong Kong.

Later that year, she signed up as a volunteer advisor for the UNDP Cambodia's newly launched Bluetribe 2020 Young Entrepreneur Incubator Programme, helping entrepreneurs with co-founders' agreements and contract law issues, as well as business registration. While Piny was no longer working in the law, her UTS studies and corporate legal experience were integral to her contributions at CCF and the Bluetribe Incubator. Piny's career has recently taken a new turn - she is drawing on her personal story and her UTS experience to help people live more impactful and purposeful lives.

With a Bachelor of Laws and several years as a successful commercial lawyer under her belt, Sarah Romanous returned to UTS to further her knowledge with a Master of Laws majoring in Intellectual Property.

"I had been practising law for a few years, and was starting to practise in the commercialisation of intellectual property, which was a new area for me. I decided that a proper foundation through a postgraduate course would fast track my understanding."

When contemplating her return to study, Sarah says it was her experience studying undergraduate law at UTS, as well as the flexible study options for postgrad students, that assured her UTS was the right decision.

Do you want to study a single subject without committing to a full degree? You can! It's called non-award study and it's a great way to upgrade your skills or just learn more about something you enjoy. What's even more exciting is that any subjects you complete may be recognised in future study. To apply, visit uts.edu.au/non-award-study

ENGLISH LANGUAGE PROFICIENCY

If you've studied overseas you may need to demonstrate your English proficiency by completing an English language test or program recognised by UTS. The English language results needed to meet UTS English language requirements for entry are listed below.

- IELTS (Academic): 6.5 overall, writing 6.0
- TOEFL (Internet-based): 79-93 overall, writing 21
- PTE (Academic): 58-64
- CAE: 176-184
- AE5/AE6 (PASS): AE5

The TOEFL Paper Based Test is currently being phased out by TOEFL. UTS will continue to accept TOEFL PBT scores, provided the test was taken within the two years prior to application at UTS.

These requirements may apply to you, even if you are not an international student. Visit uts.edu.au/english-language-requirements to find out more.

RECOGNITION OF PRIOR LEARNING

Credit recognition may be granted on the basis of the recent successful completion of equivalent law subjects from another recognised university. Conditions apply. Students should refer to the credit recognition rules via handbook.uts.edu.au/law

FEES

If you're studying a postgraduate by coursework degree, you'll need to pay tuition fees. You can find out more about what your degree will cost at uts.edu.au/tuition-fee-calculator

If you do have to pay a fee and you're a local student, you may be eligible for FEE-HELP, an Australian Government loan scheme. Using FEE-HELP means you don't have to pay for your tuition fees up front. More information can be found at uts.edu.au/government-help-schemes

You can choose to repay your FEE-HELP loan simply by notifying your employer who will then withhold your payments through the PAYG tax system. You can also make payments directly to the Australian Taxation Office (ATO). And, if your postgraduate degree is related to your employment, your tuition fees may be tax deductible. ALUMNI ADVANTAGE


