

# Becoming a lawyer

Did you know you need to complete practical legal training to be admitted to legal practice?

If you are looking to use your legal qualification to start a career in legal practice, you can add practical legal training to your degree at UTS. Practical legal training (PLT) is a mandatory requirement for admission to practise law in NSW, and UTS will get you there.

#### LEGAL PRACTITIONERS, LAWYERS, SOLICITORS AND BARRISTERS


The Supreme Court of NSW may admit a person to the Australian legal profession as an Australian lawyer if the person holds an Australian practising certificate. A practising certificate is obtained through completing PLT at UTS.

Legal practitioner and lawyer are broad terms that refer to both solicitors and barristers. For the most part, solicitors provide general legal advice to their clients. Their role also includes settling disputes, drafting documents, directing negotiations and/or representing their clients in court or tribunal proceedings.

Barristers are specialist advocates and spend the majority of their practice presenting cases in court or formal hearings on behalf of their clients.
Barristers are likely to specialise in certain areas of the law, for example criminal law. They also provide specialist legal advice and act as mediators, arbitrators, referees or conciliators. Barristers are independent practitioners and are generally referred clients by solicitors who provide the background 'brief' on a case.

# What you'll learn

The PLT program consists of 3 core subjects outlined in the table below. Students can then choose from Stream A or B to complete their studies. Practical experience is 0 credit points and no fees.

#### **3 CORE SUBJECTS (18 CPS)**

75424 Skills & Wills Practice

75423 Litigation Practice

75422 Property and Commercial Practice



#### **STREAM A**

75411 Practical Experience of 65 days Stream A students receive 6 credit points of RPL



#### PRACTICAL EXPERIENCE

As part of your PLT, you'll get the chance to dive into the real world of legal work (either 13 or 4 weeks full-time or equivalent depending on stream chosen). It's not about the credits; it's about the hands-on experience you gain in a legal office setting. We want you to reach the level of a starting lawyer, and if you've already had some legal work experience before joining us, you may be eligible to have those days counted too. # Enrolment and fees

#### **ENROLMENT**

The PLT can be undertaken as part of the Bachelor of Laws (using electives) or upon completion of your Bachelor of Laws, combined Bachelor of Laws degree, Juris Doctor or combined Juris Doctor degree.

If you are a current Bachelor of Laws student, you can undertake the PLT as part of your elective suite. You can enrol in these subjects as you would any other elective. Subjects will be charged the same as any other undergraduate elective.

If you undertake the PLT as a standalone qualification after completing your Bachelor of Laws or JD, you will be enrolled in the **Graduate Certificate** in **Professional Legal Practice**. You can apply for these courses through the application portal.

#### **2025 ALUMNI ADVANTAGE**

If you are a UTS alumnus, you may be eligible for a 10% reduction in fees through the Alumni Advantage Program.
