CAREER OPTIONS

Career options include registration as a migration agent and specialist work in the migration advice and policy industry. This program also benefits lawyers, who are in the unique position of being able to enhance their professional skillset with valuable migration law and practice expertise.

Registering as a Migration Agent

Graduates intending to work in the area of migration practice have the required knowledge and skills to provide immigration assistance. They are eligible to sit for a Capstone exam approved by the Office of Migration Agents Registration Authority (OMARA) to seek registration as a migration agent.

Lawyer seeking to specialise

Australian lawyers holding a current practising certificate are not required to register with the Migration Agents Registration Authority to lawfully provide immigration advice. This course offers an opportunity to advance their knowledge of this complex area of law and practice. Appropriately qualified lawyers are eligible for credit recognition for two subjects.
