## WHO WE ARE AND WHAT WE DO

---

The Centre's five academics lead our six streams of strategic focus:

- **Health Care Transitions:** Professor Jane Phillips leads the Care Transitions stream which focuses on building the evidence at the patient, health professional and systems levels to better support people with chronic care needs transitioning into palliative care.
- **Clinical Interventions:** Dr Phillip Newton leads the Clinical Interventions stream. This stream focuses on the design, implementation and management of clinical trials focusing on health services evaluation, symptom management and evaluation of interventions to improve outcomes for individuals with chronic illness.
- **Health Outcomes and Measurement:** Dr Tim Luckett leads the Health Outcomes and Measurement stream. This stream is focused on improving expertise in patient reported outcomes, development and evaluation of complex interventions and health economics. Dr Luckett is also the Program Coordinator for Improving Palliative Care through Clinical Trials (ImPaCCT) (<http://www.impact.med.unsw.edu.au>).
- **Population Health:** Dr Sally Inglis leads the Population Health stream which focuses on using large data sets for chronic and complex health services planning and research.
- **Reducing Health and Social Disparities:** Dr Michelle DiGiacomo leads the Reducing Health and Social Disparities stream. She works with a range of populations, including Aboriginal people, older people, and those from culturally and linguistically diverse populations. In particular, this work focuses on understanding issues impacting individuals living with chronic health conditions and intervening to assist and access appropriate care.
- **Translating Research into Practice:** Dr Sally Inglis also leads the Translating Research into Practice program. Dr Inglis completes systematic reviews to develop evidence-based practice strategies and works on strategies to improve health outcomes, including application of telemedicine.

## CORE MEMBERS

---

**Jane Phillips, PhD, RN** *Centre Director and Professor Nursing (Palliative Care)*



Professor Phillips is the current Director of the Centre for Cardiovascular and Chronic Care. Prior to this appointment, Professor Phillips was the inaugural Professor of Palliative Nursing at the University of Notre Dame, Australia – Sydney and attached to the Cunningham Centre for Palliative Care, based at Sacred Heart Hospice, St Vincent's Hospital, Sydney. Where she co-led the Palliative Care Clinical Trials Unit

at Sacred Heart and St Vincent's Sydney, overseeing the implementation of more than a dozen investigator driven palliative care clinical trials across the campus. She is also a Visiting Professor, Sydney University School of Medicine, Sydney.

Professor Phillips's program of research is focused on improving care outcomes for people in the last year of life by strengthening the nexus between research, policy and practice. She is currently undertaking studies to evaluate non-pharmacological interventions to improve breathlessness, delirium, health services research to improve care outcomes for older people with cancer and to improve symptom management for older people in residential aged care and translational research in the areas of pain management and symptom management. She has developed and evaluated nurse coordinated models of palliative care and has extensive experience in cancer and chronic disease nursing, and research.

**Patricia Davidson, Immediate Past Director**



Professor Davidson is the Immediate Past Director of the Centre for Cardiovascular and Chronic Care (2008-2013). Prior to taking up her new appointment as the Dean of the Johns Hopkins School of Nursing in September 2013, she held the Chair of Professor of Cardiovascular Nursing Research at St Vincent's Hospital, Sydney.

Professor Davidson has an established program of research in supporting individuals living with chronic conditions and developing innovative models of transitional care. A primary objective of her work has been to improve the cardiovascular health of underserved populations through development of innovative, acceptable, and sustainable initiatives within Australia and beyond. She is a Fellow of the Australian College of Nursing, Fellow of the American Heart Association, Fellow of the Preventive Cardiovascular Nurses Association and Fellow of the American Academy of Nursing. She is Counsel General of the International Council on Women's Health Issues and actively involved in the international activities of Sigma Theta Tau International.

Since 2003, Professor Davidson has supervised and mentored more than 33 researchers. She continues to play an active role in the Centre where she continues to be a co-investigator on numerous grants and is co-supervising a number of PhD students.



**Michelle DiGiacomo, PhD, MHSc(Hons), BA**  
*Senior Research Fellow/Senior Lecturer (Research)*



Dr Michelle DiGiacomo leads the Reducing Health and Social Disparities stream in the Centre. Her program of research appreciates the contexts within which individuals, families, and communities negotiate, cope, and adjust to living with chronic conditions. Her work underscores the importance and utility of tailoring health service initiatives to meet the diverse needs and preferences of individuals and groups.

From May - September 2014, Michelle was a visiting scholar at Johns Hopkins University in Baltimore as part the UTS Professional Experience Program. Her extended visit enabled her to participate in seminars and community engagement initiatives, attend lectures, facilitate workshops, and develop and trial relationships with potential collaborators and co-authors. She presented her research, facilitated research skill development in JHU staff and students, provided consultation regarding tobacco control initiatives at the institution level, and met with new and established Faculty members. She completed a Masters of Public Health subject offered by the Bloomberg School of Public Health summer Institute which was delivered in a framework of social justice Based on her ongoing contributions to JHU's School of Nursing, she was appointed Adjunct Faculty.

**Sally Inglis, PhD, RN, BN, BHSc(Hons), NFESC, FAHA**  
*Senior Research Fellow*

*Currently supported by NSW Cardiovascular Research Network Life Sciences Fellowship supported by the Heart Foundation and the NSW Office for Medical Research*

Dr Sally Inglis has a keen interest in chronic cardiovascular disease and has undertaken research across a variety of cardiovascular conditions and research methodologies throughout her research career. Her current research program examines the evidence for the use of telemonitoring and structured telephone support to support people with chronic heart failure and the use of technology-based education interventions for people with chronic heart failure as well as the epidemiology, management and outcomes of people with peripheral arterial disease.



Sally's research into the use of telemonitoring and structured telephone support has been incorporated into several national and international heart failure guidelines.

She is currently supported by a prestigious OMR-CVRN Life Sciences Research Fellowship from the Heart Foundation and the NSW Office for Medical Research which is supporting her to continue her program of research to improve outcomes for Australians with chronic cardiovascular disease.



## **Tim Lockett, PhD, BSc (Hons) Research Fellow**



Dr Tim Lockett is Program Coordinator for the NSW clinical trials collaborative in palliative care, ImPaCCT ([www.impacct.med.unsw.edu.au](http://www.impacct.med.unsw.edu.au)) and contributes to a range of projects and academic activities aimed at improving person-centred care for people with life-limiting illness. In 2014, these included coordination of the IDEAL Project and cancer pain management program outlined below as well as a phase II trial of melatonin for prevention of delirium and study of impact of corticosteroids on sleep quality in hospital in-patients with advanced cancer. Tim also managed an online survey of current practice regarding advance care planning for people with chronic kidney disease.

## **Phillip Newton, PhD RN, BN (Hons) Senior Research Fellow**



Dr Phillip Newton has an established record of cardiovascular research and in particular heart failure research. The main focus of his research is testing different therapeutic approaches for breathlessness management in advanced heart failure. Dr Newton has a strong record of obtaining nationally competitive funding from the NHMRC, ARC and Heart Foundation NSW CVRN and other major funding schemes.

Dr Newton leads a number of cardiovascular clinical studies He currently is a member of the Executive Committee for the Cardiovascular Nursing Council of the Cardiac Society of Australia and New Zealand and the Australasian Cardiovascular Nursing Council. In 2013, Dr Newton was recognised for his outstanding contribution to cardiovascular health by being elected a Fellow of the American Heart Association.

### Aboriginal Medical Service Western Sydney (AMSWS)

The Centre continues to work in collaboration with the Aboriginal Medical Service Western Sydney (AMSWS). Members of our team work closely with Aboriginal Health Workers and General Practitioners to develop and implement a range of service initiatives designed to improve access to culturally appropriate care and build Aboriginal health workforce capacity. Such initiatives include a smoking cessation clinic, women's exercise programs, and adult health check screening days in the local Aboriginal community.



### St Vincent's Hospital, Sydney

The Centre has a clinical research unit based at St Vincent's Hospital; this allows us to collaboratively engage in teaching and research within the clinical setting.



### ImPaCCT (Improving Palliative Care through Clinical Trials)

The Centre is a key member of ImPaCCT thanks to Prof Davidson and now Prof Phillip's involvement as investigators and Dr Lockett's role as ImPaCCT's Program Coordinator. ImPaCCT is a NSW-wide collaborative research group that focuses on palliative care. Funded since 2010 by the Cancer Institute NSW, ImPaCCT aims to build a multi-institutional research agenda with active involvement from consumers and all major disciplines working in palliative care.

ImPaCCT continues to develop its portfolio of studies in health service evaluation, symptom assessment and management and doctor-patient communication. New collaborators to join ImPaCCT in 2014 include palliative care professionals from Western Sydney Local Health District and ACT. Involvement continues from clinical staff from Calvary Health Care Sydney, HammondCare, Hunter New England Local Health Network, South-Eastern Sydney Local Health District and Sacred Heart St Vincent's as well as researchers from the University of New South Wales, University of Sydney and The Ingham Institute.

### **Advanced Care Planning in the Emergency Department (ACP-ED)**

Advance care planning is the process by which patients make decisions that can guide their future health care in the event they become unable to speak for themselves (e.g. following cardiac arrest). Advance care plans, based on the ethical principle of respect for patient autonomy, reflect patients' values and concerns, and require patients to understand their medical condition, and also the benefits and burdens of possible treatments.

Although advance care planning is widely endorsed and uptake is increasing, research suggests that plans are often not implemented and patients receive care that may not have been in accordance with what they would have chosen for themselves. Problems are most pronounced in Australia's Emergency Departments (EDs), where patients with advanced life-limiting illness often receive inappropriate and aggressive life-sustaining treatments and are hospitalised unnecessarily instead of receiving the palliative care and support for self-management they would have preferred.

Funded by the CSIRO, this project investigated the barriers and facilitators to the utilisation of advance care plans in the emergency department and included a systematic review of online advance care directives.

### **Breast Screen Promotion in Sri Lankan and Indian women in NSW: engaging community, media, research and health (Cancer Institute NSW Evidence to Practice Grant, 2014)**

Breast and cervical cancers are major causes of mortality in women in India and Sri Lanka. Screening rates for Indian and Sri Lankan women living in Australia are amongst the lowest in the country (Cancer Institute 2014), yet belong to one of the fastest growing population groups in NSW. In addition, in recent years Tamil speaking refugees from Sri Lanka have also increased (19,395 people from Sri Lanka have settled in NSW since 1991), posing a unique situation with both newly arrived Tamil refugees with low English language proficiency and a relatively well established Tamil speaking communities in NSW.

To address this problem, this multidisciplinary project is using a multi-pronged approach involving media, community engagement, community champions, bilingual talks, culturally relevant resources and group bookings. This project also includes strategies to strengthen the cultural competency of breast screening services.



## Chronic Kidney Disease – Advance Care Planning Program

This project is funded by Kidney Health Australia to inform future intervention developments in advance care planning for people with chronic kidney disease. Dr Lockett has coordinated an online survey of current practice, which closed after receiving responses from 430 health professionals across Australia.

Results from the survey suggest that advance care planning occurs for only a minority of people with chronic kidney disease and that the quality of advance care planning is often poor. Semi-structured interviews are underway with health professionals in Melbourne to understand their perspectives in more depth. This information will be used to develop materials for conducting advance care planning with people with chronic kidney disease, addressing issues relating to dialysis and worsening cognitive impairment associated with the condition.

## Developing Gender Based Women's Health Initiatives in the Illawarra

This project developed a gender based analysis (GBA) exploring the issues and experiences of women living with chronic conditions in the Illawarra and was completed in 2014.

An environmental scan and integrative literature review using the lens of GBA assisted in the identification of research and recommendations for a gendered based approach for women and chronic disease. The contributions of 15 community members and 6 professional stakeholders during a series of focus groups helped to identify barriers and facilitators and describe the socio-cultural considerations to providing a gender based approach for chronic conditions and women's health in the Illawarra. The participants also provided descriptions of women's journeys through the health care system and the interface between primary, secondary and tertiary care.

This research has leveraged important information to inform an evidence-based approach to health care service planning and policy development in the future.

## **Doubly disadvantaged: harnessing elements of resilience and establishing information for systems change (ARC LP120200484)**

Our partnership project with the Aboriginal Medical Service Western Sydney (AMSWS) has continued to explore the experiences, needs, and services available to Aboriginal families who have a young child with a disability. This project is using a community-led approach to engage community members, health and other service providers in Western Sydney to: better understand current availability of Aboriginal early childhood disability services; the family journey to accessing support; acceptability and utility of support services; develop education and resources for parents, children, and support services, and to inform design and delivery of services. We aim to provide practical, tangible and measureable solutions to improve access to care for Aboriginal children and support for families and the community.

In 2014, we interviewed carers of children with a disability and began conducting follow-up interviews. We were also fortunate to begin working with a talented PhD student, Anna Green, deemed by the AMSWS project team to have an excellent academic background and suit of interpersonal skills required to successfully and meaningfully contribute to this project. To complement the carer interviews, Anna will be looking at service providers and organisations external to the Aboriginal Community Controlled Health sector. Exploring the experiences of these providers and organisations will contribute to the larger picture of service provision and help to improve service access. Anna successfully completed her Stage 1 assessment in November and will begin data collection in early 2015. She receives regular ongoing cultural mentorship by our partners at the AMSWS.

## **Heart Failure Snapshot**

The NSW Heart Failure Snapshot was a prospective audit of consecutive patients admitted to 25 participating facilities across New South Wales and the ACT over a one month period with an admission diagnosis of acute decompensated heart failure. The primary aim of the Snapshot was to obtain a representative cross-sectional view of acute heart failure patients and their management across the broad range of acute hospital services in NSW ranging from small rural hospitals to large tertiary referral centres. In total, 811 participants were recruited. Most patients were elderly with a mean age of 77 years with a slight excess of men. Chronic lung disease, renal disease and diabetes were the most common comorbidities. Intercurrent infection, atrial arrhythmias and problems with diet or fluid management were identified as the most common precipitants.

The NSW heart failure snapshot has highlighted the advanced age, multiple co-morbidities and high prevalence of frailty among patients admitted to NSW hospitals with acute decompensated heart failure. Use of evidence-based therapies particularly ACE inhibitors and beta blockers was surprisingly low with little evidence of any attempt to introduce these therapies during hospitalisation.

The extent to which co-morbidities and frailty contribute to the low utilisation of evidenced-based therapies is being explored in ongoing analyses. We anticipate that the results of the Heart Failure Snapshot will inform the development of strategies to improve access of heart failure patients to multi-disciplinary care programs and increased uptake of evidence-based therapies for CHF.

## IDEAL Project

The IDEAL Project was a cluster RCT aimed at evaluating the cost-effectiveness of case conferencing in improving the quality of end of life care for aged care residents with advanced dementia. The trial closed at the end of 2014, and analysis of results is now underway.

Funded by the Department of Health, the IDEAL Project took place at 20 aged care facilities in Sydney and Brisbane from early 2013. Nurses from each of 10 facilities randomised to the intervention arm were trained to be Palliative Care Planning Coordinators (PCPCs) who coordinated case conferences with family and general practitioner involvement, and documented and monitored resulting palliative care plans. The Sydney project team was based with the Centre while the Brisbane team were based at Queensland University of Technology. The primary outcome is satisfaction with end of life care as perceived by a family member of each resident.

## Pain Pathway Program

This program began in 2010 and is aimed at developing, piloting and evaluating a clinical pathway for screening, assessment and management of cancer pain.

In 2014, a pilot was carried out of guidelines developed by the team and launched in late 2013, as well as a screening system for pain, audit and feedback system to inform quality improvement, and patient-held resources aimed at improving self-management, doctor-patient communication and coordination between service providers.

These resources, along with a QStream online education module for health professionals will be evaluated by means of a stepped wedge cluster RCT that in 2014 received competitive grant funding from the National Breast Cancer Foundation. The trial will be managed by a team based within the Centre and will run from 2015 until 2018



## Peripheral arterial disease in the 45 and Up Study

Led by Dr Inglis and supported by the NSW Cardiovascular Research Network (NSW CVRN), this study will examine the epidemiology, predictors of health outcomes and healthcare utilisation of participants of the 45 and Up Study with peripheral arterial disease. Currently, little is known of the epidemiology and healthcare and economic burden of peripheral arterial disease in Australia. In the absence of large-scale epidemiological studies in peripheral arterial disease in the general population, best-available evidence on the epidemiology of peripheral arterial disease is non-specific episodic hospitalisation data and small-scale cohort studies in geographic areas that have undertaken screening to confirm and identify cases. This study is significant as it will be the only community-based cohort study of peripheral arterial disease in Australia which includes both men and women.

## Strategies to improve heart disease outcomes in Australian women (ARC DP 120101148)

Heart disease is the major killer of Australian women, yet many women remain unaware and underestimate their risk. Heart disease occurs more commonly in older women who face numerous other health and social life changes. Building on work the Centre has undertaken previously, in this project, we are testing a novel cardiac rehabilitation program designed specifically for women. We will be investigating the use of a gendered approach to healthcare through developing strategies to improve women's heart health in Australia, including evaluating, in a randomised controlled trial (RCT), the benefit of a group-based tailored program.

A literature review documenting elements of cardiac rehabilitation programs for women was completed in 2014. We have undertaken consultation with Blacktown and Mt Druitt hospitals who will be implementing the RCT in the coming months. Cardiac rehabilitation staff are excited to be involved in trialling this program which previously received high praise from participants and staff alike.

The WHICH? II Trial, is a pragmatic, multicentre, randomized head-to-head trial of a standard, post-discharge chronic heart failure management incorporating a combination of at least one home visit and hospital outpatient for metropolitan-dwelling patients and structured telephone support for patients living more remotely versus a more intensive program of management targeting those most at risk of recurrent and costly hospital stay through the application of standard care plus additional support with structured telephone support for high risk metropolitan-dwelling patients and at least one home visit for those patients usually reliant on remote management.

This NHMRC funded study will recruit 800 patients from four tertiary hospitals (in NSW, SA and VIC). The WHICH? II study will determine if a more intensive, targeted management approach (combining the evidence to date around CHF management programs) will result in more cost-effective health care in typically older and fragile patients with significant comorbidity. The WHICH? II study is led by Professor Simon Stewart from the Australian Catholic University.



## PILOT STUDIES

### **Dexamethasone Sleep Quality Study**

*Dr Janet Hardy, Dr Tim Lockett*

In his role as Program Coordinator for ImPaCCT, Dr Lockett coordinated involvement of three NSW sites in a Brisbane-led study of the effects of corticosteroids on sleep quality in hospital in-patients with advanced cancer.

### **Fan Activity and Breathlessness (FAB) Study**

*Dr Miriam Johnson, Prof Jane Phillips, Prof David Currow, Dr Sara Booth, Prof Lawrence Lam*

This phase II study aims to test the feasibility of conducting an adequately powered large, multi-centre, multi-national randomised controlled clinical trial comparing the efficacy of a hand held fan and exercise advice with exercise alone in increasing activity levels in people with optimally treated breathlessness from any cause. The team has been recruiting people with optimally treated breathlessness from any cause with a MRC score  $\geq 3$  attending cardio-respiratory, oncology and palliative care outpatient clinics and day hospices at three UK sites and 2 Australian sites.

The patients randomised to the intervention group are receiving a hand held battery operated fan ('fan') plus exercise advice, while the participants in the comparator group receive exercise advice only. The primary outcome measure is an i) Increase in average number of steps per day, as measured by an ActivPAL Monitor; and the secondary outcome measures are: ii) to assess the usefulness/tolerability of proposed phase III outcome measures.

Trial Registration: Australian and New Zealand Clinical Trials Registry (ACTRN12614000525684).

### **Phase II RCT of melatonin for prevention of delirium in inpatients with advanced cancer**

*A/Prof Meera Agar, Prof Katherine Clark, A/Prof Richard Chye, Dr Brian Le, Dr Peter Eastman, Dr Tim Lockett*

In his role as Program Coordinator for ImPaCCT, Dr Lockett coordinated a phase II RCT of melatonin for prevention of delirium in hospital in-patients with advanced cancer, which is due to complete in mid-2015. A collaboration with the national Palliative Care Clinical Studies Collaborative (PaCCSC), this study will progress to Phase III if funded by the NHMRC. Prevention of delirium has potential to impact mortality and morbidity as well as be substantially cost saving.

### Cochrane Collaboration Reviews

*Dr Sally Inglis*

Cochrane Reviews are recognised internationally as the highest standard in evidence-based healthcare. Cochrane Reviews systematically synthesis the primary research evidence on interventions, providing clinicians, consumers and policy-makers to make informed decisions regarding interventions for a variety of health states and disease.

Dr Inglis is a member of the Editorial Board of the Cochrane Collaboration Heart Review Group. During 2014 Dr Inglis led three large Cochrane Reviews of interventions to support people with chronic cardiovascular disease, including updating the telemonitoring and structured telephone support for people with chronic heart failure Cochrane Review, that she lead in 2010, in partnership with an international team,

Dr Inglis is also leading a team that has been undertaking (comprised mainly of CCCC members) a review of self-management interventions to support people with peripheral arterial disease which is the first review of this topic based on the current literature. This research was presented at the World Congress of Cardiology in Melbourne in May 2014.

In partnership with Professor Patricia Davidson and Associate Professor Cheryl Dennison-Himmelfarb from Johns Hopkins University, Dr Inglis is also leading an international team of researchers to complete a Cochrane Review examining technology-based health education for people with chronic heart failure.

Dr Inglis is also an author on a Cochrane Overview of non-pharmacological management interventions for COPD which is led by one of her PhD student's Ms Rebecca Disler.
